1. Consent Agenda

- December meeting minutes

2. Road Master Report

- Corey explained that he obtained a quote for new tires from MarBar for \$6000.00
- o The Auger for the Mack Truck needs attention.
- Wilkinson suggested a list of roads for each driver.
- o The availability of Jerry as backup snowplow driver was confirmed.
- Corey will attend the NAREMA meeting on February 5.

3. Business

- a. Zoning Amendment
- b. SALDO amendment
 - O Todd reported that he is looking to advertise the zoning sign amendment with the Subdivision and Land Development Ordinance (SALDO).
 - Todd is awaiting county feedback on a previously submitted zoning sign amendment.
- c. Dollar General
 - Holding Tank Agreement (DEP) has not been presented to the Township yet.
- d. Ivan Fisher
 - Jon Holmes is still waiting on information from Brandon. There are still concerns regarding the infiltration trench only on one side. It is recommended there be trenches on both sides.

e. Township Building

- The bids are out and questions and requests for information are coming in.
 And addendums will need to be drafted.
- The recommendation on bid award will be emailed on February 7th, with the formal award and documentation to follow at the February 10th meeting.
- Englebert stated the Church is ok and we will need to come up with an agreement.
- f. Independent Audit:

- Woerner initiated a discussion about the need for an independent audit, particularly considering the building project.
- The board discussed the role of elected auditors and the potential cost of an independent audit.
- o Danielle Helwig was tasked with investigating audit costs and options.
- g. Treasurers Bond: Do we need to increase the Treasurers Bond regarding the building loan. Danielle will verify with the bank.
